**BACKGROUND**

The Fiscal Year 2021-22 State Budget Act (Senate Bill 129) appropriated \$985 million from the Coronavirus Fiscal Recovery Fund, established by the American Rescue Plan Act of 2021, to the State Water Board for payments to community water systems to forgive residential and commercial customer arrearages that accrued during the COVID-19 pandemic relief bill period (March 4, 2020 through June 15, 2021) (the Water Arrearages Program).

A Budget trailer bill (Assembly Bill 148) added Chapter 4.7, commencing with section 116773 of part 12 of division 104 to the Health and Safety Code to establish requirements for the California Water and Wastewater Arrearage Payment Program. The State Water Board adopted the resolution establishing the Guidelines to establish the requirements for the California Water and Wastewater Arrearage Payment Program on September 21, 2021 and amended the Guidelines on December 7, 2021.

Since sufficient funds remain after implementation of the Water Arrearages Program, the Budget Act of 2021 appropriates the remaining funds for payments to wastewater treatment providers, or wastewater billing entities that are designated as the billing entity for a wastewater treatment provider, to forgive residential and commercial customer arrearages that accrued during the COVID-19 pandemic bill relief period of March 4, 2020 through June 15, 2021. The draft amendments to the Guidelines establish the criteria and processes the State Water Board will use to administer the Wastewater Arrearages Program.

## **DOCUMENT AVAILABILITY**

The Draft amendments to the Guidelines to add the Wastewater Arrearages Program were made available for public comment on December 17, 2021. 
