TRANSMITTIAL OF TENTATIVE CLEANUP AND ABATEMENT ORDER FOR THE FORWARD LANDFILL, SAN JOAQUIN COUNTY

Enclosed for your review and comment is a tentative Cleanup and Abatement Order (CAO) which has been prepared to address the volatile organic compounds (VOCs) detected in drinking water supply wells within the known extent of the plume emanating from the Forward landfill.
