## State Water Resources Control Board

### **Notice of Water Right Applications A032901, A032902, A032903, A033032 and A033067**

Vicini Family Investments LLC has filed five applications to appropriate water by permit with the State Water Resources Control Board (State Water Board), Division of Water Rights. The projects associated with the applications are located in Amador County and would divert water from the Cosumnes River and Mokelumne River stream systems.

#### **Summary of Water Right Application A032901**

**Date of Filing:** The application was filed with the State Water Board on January 30, 2018.

**Source of Water:** The source of water is an Unnamed Stream tributary to North Fork Dry Creek thence Dry Creek thence the Mokelumne River.

**Season of Diversion:** The season for diversion of water is from September 1 of each year through June 14 of the succeeding year.

**Amount:** The maximum amount of water requested for diversion is 63.7 acre-feet per year, which would be collected in two on-stream reservoirs.

**Points of Diversion:** Water will be diverted from two points:

- The first point of diversion is located at North 1,949,918 feet and East 6,925,222 feet by California Coordinate System, Zone 2, North American Datum 1983, located within the Northwest quarter of the Northeast quarter of Section 35, Township 8 North, Range 11 East, Mount Diablo Base and Meridian.
- The second point of diversion is located at North 1,950,051 feet and East 6,925,990 feet by California Coordinate System, Zone 2, North American Datum 1983, located within the Northeast quarter of the Northeast quarter of Section 35, Township 8 North, Range 11 East, Mount Diablo Base and Meridian.

**Purposes of Use:** The purposes of use for diverted water are irrigation and stockwatering.

**Place of Use:** The place of use for diverted water consists of 6 acres for irrigation and two ponds for stockwatering, located within the North half of Section 35, Township 8 North, Range 11 East, Mount Diablo Base and Meridian.

## **Summary of Water Right Application A032902**

**Date of Filing:** The application was filed with the State Water Board on January 30, 2018.

**Source of Water:** The source of water is an Unnamed Stream tributary to Willow Creek thence Laguna Creek thence the Cosumnes River.

**Season of Diversion:** The season for diversion of water is from November 1 of each year through June 14 of the succeeding year.

**Amount:** The maximum amount of water requested for diversion is 607.9 acre-feet per year, which would be collected in three on-stream reservoirs.

**Points of Diversion:** Water will be diverted from three points:

- The first point of diversion is located at North 1,930,234 feet and East 6,864,400 feet by California Coordinate System, Zone 2, North American Datum 1983, located within the Southwest quarter of the Southwest quarter of Section 13, Township 7 North, Range 9 East, Mount Diablo Base and Meridian.
- The second point of diversion is located at North 1,930,014 feet and East 6,864,418 feet by California Coordinate System, Zone 2, North American Datum 1983, located within the Southwest quarter of the Southwest quarter of Section 13, Township 7 North, Range 9 East, Mount Diablo Base and Meridian.
- The third point of diversion is located at North 1,929,983 feet and East 6,864,994 feet by California Coordinate System, Zone 2, North American Datum 1983, located within the Southeast quarter of the Southwest quarter of Section 13, Township 7 North, Range 9 East, Mount Diablo Base and Meridian.

**Purposes of Use:** The purposes of use for diverted water are irrigation and stockwatering.

**Place of Use:** The place of use for diverted water consists of 139 acres for irrigation and three ponds for stockwatering, located within sections 13, 14, and 23, Township 7 North, Range 9 East, Mount Diablo Base and Meridian.

## **Summary of Water Right Application A032903**

**Date of Filing:** The application was filed with the State Water Board on January 30, 2018.

**Source of Water:** The source of water is an Unnamed Stream tributary to Willow Creek thence Laguna Creek thence the Cosumnes River.

**Season of Diversion:** The season for diversion of water is from November 1 of each year through June 14 of the succeeding year.

**Amount:** The maximum amount of water requested for diversion is 803.7 acre-feet per year, which would be collected in three off-stream reservoirs.

**Points of Diversion:** Water will be diverted from three points:

- The first point of diversion is located at North 1,931,708 feet and East 6,860,709 feet by California Coordinate System, Zone 2, North American Datum 1983, located within the Northeast quarter of the Southwest quarter of Section 14, Township 7 North, Range 9 East, Mount Diablo Base and Meridian.
- The second point of diversion is located at North 1,931,665 feet and East 6,860,773 feet by California Coordinate System, Zone 2, North American Datum 1983, located within the Northeast quarter of the Southwest quarter of Section 14, Township 7 North, Range 9 East, Mount Diablo Base and Meridian.
- The third point of diversion is located at North 1,931,639 feet and East 6,861,692 feet by California Coordinate System, Zone 2, North American Datum 1983, located within the Northwest quarter of the Southeast quarter of Section 14, Township 7 North, Range 9 East, Mount Diablo Base and Meridian.

**Purposes of Use:** The purposes of use for diverted water are irrigation, industrial, and stockwatering.

**Place of Use:** The place of use for diverted water consists of 139 acres for irrigation, industrial use at a gravel plant, and three ponds for stockwatering, located within sections 13, 14, and 23, Township 7 North, Range 9 East, Mount Diablo Base and Meridian.

## **Summary of Water Right Application A033032**

**Date of Filing:** The application was filed with the State Water Board on March 19, 2019.

**Source of Water:** The source of water is an Unnamed Stream tributary to Willow Creek thence Laguna Creek thence the Cosumnes River.

**Season of Diversion:** The season for diversion of water is from November 1 of each year through June 14 of the succeeding year.

**Amount:** The maximum amount of water requested for diversion is 278.9 acre-feet per year, which would be collected in one on-stream reservoir and one off-stream reservoir.

**Point of Diversion:** The point where water will be diverted is located at North 1,933,913 feet and East 6,865,496 feet by California Coordinate System, Zone 2, North American Datum 1983, located within the Northeast quarter of the Northwest quarter of Section 13, Township 7 North, Range 9 East, Mount Diablo Base and Meridian.

**Purposes of Use:** The purposes of use for diverted water are irrigation and stockwatering.

**Place of Use:** The place of use for diverted water consists of 139 acres for irrigation and two ponds for stockwatering, located within Sections 12, 13, 14, and 23, Township 7 North, Range 9 East, Mount Diablo Base and Meridian.

## **Summary of Water Right Application A033067**

**Date of Filing:** The application was filed with the State Water Board on August 21, 2019.

**Source of Water:** The source of water is an Unnamed Stream tributary to Willow Creek thence Laguna Creek thence South Mokelumne River.

**Season of Diversion:** The season for diversion of water is from November 1 of each year through June 14 of the succeeding year.

**Amount:** The maximum amount of water requested for diversion is 49.7 acre-feet per year, which would be collected in an on-stream reservoir.

**Point of Diversion:** The point where water will be diverted is located at North 1,928,512 feet and East 6,874,028 feet by California Coordinate System, Zone 2, North American Datum 1983, located within the Northeast quarter of the Northeast quarter of Section 19, Township 7 North, Range 10 East, Mount Diablo Base and Meridian.

**Purposes of Use:** The purposes of use for diverted water are irrigation and stockwatering.

**Place of Use:** The place of use for diverted water consists of 5 acres for irrigation and a pond for stockwatering located within Section 19, Township 7 North, Range 10 East, Mount Diablo Base and Meridian.

Protests must be received by the Division of Water Rights or postmarked by **January 15, 2024**, with copy provided to the applicant.
