RESOLUTION NO. 70-27

COMMENDING THE HONORABLE CARLEY V. PORTER

KNOW ALL MEN BY THESE PRESENTS:

That on the 24th day of September, 1970, the State Water Resources Control Board, at a regular meeting held that day in Los Angeles, California, unanimously adopted and fixed its seal upon the following resolution commending the Honorable Carley V. Porter, Assemblyman for the 38th Assembly District, and ordered that it be given the widest distribution and be published in the State Water Resources Control Board's "News and Views":

WHEREAS, the State of California during the last several decades has experienced unique and massive water management problems; and

WHEREAS, the needs of all of the State's residents for a plentiful, high quality water supply and for a beautiful water environment are among the foremost of concerns in the minds of all of the people of the State; and

WHEREAS, the Legislature of the State of California responded to the needs with unique, imaginative and farsighted legislation that resulted in the State Water Project and today is resulting in a major effort to improve the quality of our waters; and

WHEREAS, Carley V. Porter has been the principal legislative force and author of every significant and major innovative program of water resources management for the State; and

WHEREAS, as principal author of the Clean Water Bond Act, which will be on the November ballot as Proposition One, he has proven responsive to the critical financial needs of local agencies and communities; and

WHEREAS, his untiring efforts in recent years to implement a broader concept of water resources management, including water quality and quantity considerations, have set an example for the rest of the nation; and

WHEREAS, most recently he has co-authored bills which established the State Water Resources Control Board and provided it with the most effective pollution control tools available to any state administration; and

WHEREAS, hundreds of distinguished Californians will gather in Los Angeles on September 24, 1970, to pay tribute to him; now, therefore, be it

RESOLVED, that the State Water Resources Control Board expresses its appreciation for his encouragement, support and guidance during the Board's formative years; and be it further

RESOLVED, that the State Water Resources Control Board congratulates Carley V. Porter on a record of water achievement that is unmatched by any single state legislator in this or any other of the fifty states; and be it further

RESOLVED, that the State Water Resources Control Board wishes him continued success in his efforts to build better and more effective water programs for California.

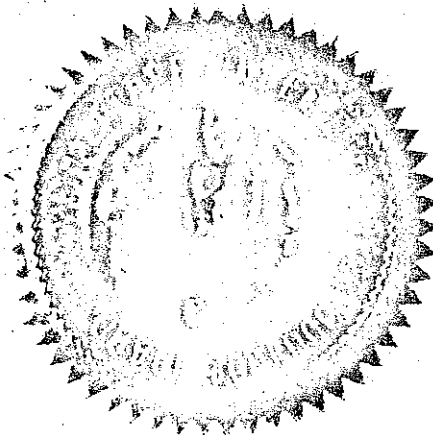
