RESOLUTION NO. 85- 7

STATE WATER RESOURCES CONTROL BOARD (SWRCB) AND DEPARTMENT OF
WATER RESOURCES (DWR) COOPERATION ON TWO WATER RECLAMATION TASKS

WHEREAS:

1. The Department of Water Resources requests the State Water Resources Control Board's cooperation in two tasks related to reclaimed water use in California.
2. The first task will be to implement a technology transfer program regarding reclaimed water for agriculture and landscape irrigation, utilizing the Board's recently published Guidance Manual, "Irrigation With Reclaimed Municipal Wastewater."
3. Workshops will be conducted at key locations throughout the state in a joint effort by the State Board, the Department of Water Resources, the Department of Health Services and the University of California Cooperative Extension at an estimated cost of \$16,000.
4. The second task will be to evaluate the feasibility of increasing the use of reclaimed municipal wastewater for ground water recharge by formation of a Scientific Advisory Panel on Ground Water Recharge at an estimated cost of \$80,000.
5. To implement these two tasks, it is proposed to: (1) prepare a Memorandum of Understanding between the State Board, the Department of Water Resources, and the Department of Health Services; (2) consummate an interagency agreement between the Department of Water Resources and the State Board for the purpose of transferring Department of Water Resources funds to the State Board; (3) prepare a contract between the State Board and the University of California Cooperative Extension; and (4) prepare separate contracts between the State Board and members of the Scientific Advisory Panel on Ground Water Recharge.
6. Funding for the conduct of these two reclamation tasks (\$96,000) is to be shared equally by the Department of Water Resources and the State Board in the amount of \$48,000 each.

THEREFORE BE IT RESOLVED:

That the State Board:

1. Approves the participation with the Departments of Water Resources and Health Services in the conduct of the reclamation tasks.
2. Authorizes the redirection of (a) \$28,000 in FY 1984-85 uncommitted contractual funds from the Division of Water Quality's 205(j) Unallocated Bond Match allocation; and (b) \$20,000 in FY 1985-86 from the Division of Water Rights' FY 1985-86 budgeted contractual allocation for reclamation activities to the Clean Water Grants Division to execute contracts for the

purposes of: (a) implementing a technology transfer program regarding reclaimed water for agriculture and landscape irrigation; and (b) formation of a Scientific Advisory Panel for Ground Water Recharge to evaluate the feasibility of increasing the use of reclaimed municipal wastewater for ground water recharge.

3. Authorizes the Executive Director to execute: (1) a Memorandum of Understanding between the State Board and the Department of Water Resources; (2) an interagency agreement between the State Board and the Department of Water Resources; (3) a contract between the State Board and the University of California Cooperative Extension; and (4) separate contracts between the State Board and individual panel members for the Scientific Advisory Panel on Ground Water Recharge.
