RESOLUTION NO. 93-23

APPROVAL OF AN ADDITIONAL STATE REVOLVING FUND LOAN FOR
OCEANSIDE WATER POLLUTION CONTROL PLANT PROJECT,
CITY AND COUNTY OF SAN FRANCISCO, PROJECT NO. C-06-4000

WHEREAS:


1. The State Water Board, on August 18, 1988, adopted the "Policy for Implementing the State Revolving Fund (SRF) for Construction of Wastewater Treatment Facilities", and amended it on September 20, 1990 and on January 21, 1993;
2. The State Water Board, on September 17, 1992, adopted the FFY 1993 SRF Loan Program Priority List which includes the Oceanside Water Pollution Control Plant project as scheduled for FFY 1993;
3. The State Water Board approved \$116.3 million of SRF loans (\$40 million on April 20, 1989, \$30 million on October 19, 1989, \$42.2 million on September 20, 1990, and \$4.1 million on October 22, 1992) for the construction of the Oceanside Water Pollution Control Plant;
4. The Division of Clean Water Programs has approved the project report, and the draft revenue program for the construction of Oceanside Water Pollution Control Plant; and
5. The information contained in the EIR (State Clearinghouse No. 86120209) prepared for Oceanside Water Pollution Control Plant project, has been reviewed and considered, and it has been determined that:
 - (a) Changes or alterations have been required in, or incorporated into, the project which avoid or substantially lessen the potentially significant environmental impacts identified in the EIR with respect to the following aspects of the project: (i) water quality impacts will be mitigated by using permeable pavement materials to decrease runoff, designing the plant to allow drainage of water to deeper soils or to the plant, and using wells to monitor saltwater intrusion into groundwater due to construction dewatering; and (ii) impacts to cultural resources will be mitigated by stopping construction when previously unidentified resources are encountered and using a qualified archeologist to evaluate and report the site.
 - (b) With respect to the other potentially significant environmental impacts identified in the EIR, appropriate changes or alterations are within the responsibility and jurisdiction of other public agencies and such other changes or alterations have been adopted or can and should be adopted by such other agencies.

THEREFORE BE IT RESOLVED THAT:

The State Water Board approves an additional loan of \$10 million from the State Revolving Fund for Oceanside Water Pollution Control Plant project, City and County of San Francisco, Project No. C-06-4000, with a repayment period of twenty (20) years, and the first repayment to be due one (1) year after the first loan disbursement.
