STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 93-47

APPROVAL OF A STATE REVOLVING FUND LOAN FOR THE HIDDEN VALLEY LAKE COMMUNITY SERVICES DISTRICT PROJECT NO. C-06-4138-110

WHEREAS:

- 1. The State Water Board, on August 18, 1988, adopted the "Policy for Implementing the State Revolving Fund (SRF) for Construction of Wastewater Treatment Facilities" (Policy), and amended the Policy on September 20, 1990 and January 21, 1993;
- 2. The State Water Board, on September 17, 1992, adopted the FFY 1993, SRF Loan Program Priority List which includes the Hidden Valley Lake project as scheduled for a loan in FFY 1993;
- 3. The Division of Clean Water Programs has approved the project report, water conservation plan, and draft revenue program for this project; and
- 4. The Hidden Valley Lake Community Services District (HVLCSD) has certified an EIR, and a Supplemental EIR (State Clearinghouse No. 91063048) for the proposed project which have been reviewed and considered by the State Water Board, and it has been determined that:
 - (a) The HVLCSD has identified potential, unavoidable significant effects of the proposed project related to: (1) alteration of Prairie Falcon habitat; (2) loss of 41 acres of prime agricultural land; and (3) short term construction noise, and has determined that the benefits of the project outweigh the unavoidable adverse environmental effects and that such effects are acceptable.
 - Changes or alterations have been required in, or incorporated into the proposed project which avoid or substantially lessen other potentially significant environmental effects identified in the environmental document with respect to the following aspects of the project: (i) impacts from flooding will be mitigated by, valving to isolate areas in the floodplain, locating facilities and access roads one foot above the 100-year flood level; and incorporating the results of further hydrologic studies into the design of treatment and disposal facilities; (ii) water quality impacts to Putah Creek will be mitigated by encasing the transmission main in concrete at the creek crossing; (iii) potential groundwater impacts will be mitigated by designing the storage pond in accordance with Central Valley Regional Water Quality Control Board requirements by: controlling application rates in the reuse area; installation of monitoring wells and conducting an ongoing groundwater monitoring program; (iv) potential surface water impacts due to erosion control measures including hydroseeding; (v) impacts on two identified archaeological sites will be mitigated by testing to determine their significance, they will be mitigated by a mitigation recovery program.

(c) With respect to other potentially significant environmental impacts identified in the EIR, appropriate changes or alterations are within the responsibility and jurisdiction of other public agencies. Such other changes or alterations have been adopted or should be adopted by such other agencies.

THEREFORE BE IT RESOLVED THAT:

The State Water Board approves a loan of \$7.8 million for the construction of sewer lines and treatment facilities for the unsewered community of Hidden Valley Lake, Project No. C-06-4138-110, with a repayment period of twenty (20) years, and the first repayment to be due one (1) year after the completion of construction.
