# STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 2015-0037

AUTHORIZING THE EXECUTIVE DIRECTOR TO APPLY FOR, ACCEPT, AND/OR AMEND A FEDERAL CLEAN WATER ACT SECTION 319(H) GRANT AND AUTHORIZING EXECUTION AND AMENDMENT OF CONTRACTS AND GRANTS FOR SUPPORT OF THE NONPOINT SOURCE PROGRAM

### WHEREAS:

- 1. The federal Clean Water Act section 319(h) (CWA 319[h]) provides grant funds for states to implement Nonpoint Source (NPS) Programs.
- 2. The State Water Resources Control Board (State Water Board) is the designated state agency in California to administer the NPS Program.
- 3. On December 14, 1999 and January 11, 2000, the State Water Board and the California Coastal Commission, respectively, approved the Plan for California's Nonpoint Source Pollution Control Program (NPS Program Plan), which includes activities the state will undertake to control NPS pollution.
- 4. On July 11, 2000, the U.S. Environmental Protection Agency (U.S. EPA) and National Oceanic Atmospheric Administration approved California's NPS Program Plan.
- 5. U.S. EPA has notified the State Water Board that the federal Fiscal Year (FFY) 2015 CWA 319(h) grant allocation of approximately \$8,100,000 will be available to the state.
- 6. On August 4, 2014, a solicitation notice for the 2015 319(h) NPS Grant Program was released to initiate the solicitation process for CWA 319(h) for projects totaling approximately \$4,000,000.
- 7. On April 21, 2015, the State Water Board Executive Director approved projects to be funded with the 2015 CWA 319(h) grant funds.

#### THEREFORE BE IT RESOLVED THAT:

## The State Water Board:

- 1. Authorizes the Executive Director to apply for, accept, and amend, as necessary, an FFY 2015 CWA section 319(h) grant for an amount up to \$8,100,000 for support of the NPS Program.
- 2. Authorizes the Executive Director to negotiate and approve program workplans.

3. Authorizes the issuance of contracts, grants, and amendments to implement the NPS proposals presented to and approved by the State Water Board Executive Director on April 21, 2015, once the grant is received.
