**SUBJECT**

CONSIDERATION OF A PROPOSED RESOLUTION AUTHORIZING THE EXECUTIVE DIRECTOR OR DESIGNEE TO INCREASE, NEGOTIATE, EXECUTE, AND RENEW, AS NECESSARY, THE FOUNDATION FOR CALIFORNIA COMMUNITY COLLEGES (FCCC) STUDENT ASSISTANT CONTRACT.

**DISCUSSION**

The State Water Resources Control Board (State Water Board) enters into an annual contract with the Foundation for California Community Colleges (FCCC) to provide students for all State and Regional Board organizations. This contract provides funding for approximately 300 students per year. The contract is for 24 months, beginning on July 1, 2011 and terminating on June 30, 2013 and will not exceed \$11,000,000.

**POLICY ISSUE**

Should the State Water Board adopt the proposed resolution authorizing the Executive Director to negotiate and execute the proposed contract with the Foundation for California Community Colleges (FCCC) as proposed by staff?

**FISCAL IMPACT**

The resolution will authorize up to \$11,000,000 for the term of the contract 07/1/11 – 06/30/13.

**REGIONAL BOARD IMPACT**

The funds are budgeted in various programs throughout the State and Regional Board organizations.

**STAFF RECOMMENDATION**

That the State Water Board approve the resolution authorizing the Executive Director to negotiate and execute the proposed contract with the Foundation for California Community Colleges.

State Water Board action on this item will assist the Water Boards in reaching Goal 7 of the Strategic Plan Update: 2008-2012 to ensure that the Water Boards have access to information and expertise, including employees with appropriate knowledge and skills, needed to effectively and efficiently carry out the Water Boards' mission. In particular, approval of this item will assist in fulfilling Objective/Action 7.2.2 to create strategic partnerships with the State's university systems that offer degree and certificate programs applicable to the work of the Water Boards.

### **WHEREAS:**

1. The State Water Resources Control Board (State Water Board) enters into an annual contract with the Foundation for California Community Colleges (FCCC) to provide student support for the State Water Board and the California Regional Water Quality Control Board programs.
2. The contract is utilized by most State and Regional Water Board organizations as an efficient and cost-effective means of obtaining temporary student services.
3. Contract funding is for 24 months, beginning on July 1, 2011 and terminating on June 30, 2013 and would not exceed \$11,000,000.

### **THEREFORE BE IT RESOLVED THAT:**

The State Water Board authorizes the Executive Director or designee to enter into an annual contract, and any amendments thereto, with the Foundation for California Community Colleges, in an amount not exceeding \$11,000,000, to provide student support for the State Water Board and the California Regional Water Quality Control Board programs.
