**SUBJECT: DATE AND LOCATION CHANGE FOR NOTICE OF TERMINATION - WASTE DISCHARGE REQUIREMENTS ORDER NO. 01-035; BROOKDALE INN & SPA, 11570 HIGHWAY 9, BROOKDALE, CA, 95007, SANTA CRUZ COUNTY, WDID No. 3 441002001**

The Central Coast Water Board (hereafter, 'Water Board') staff sent a notice of violation on May 11, 2012, to Brookdale Inn & Spa representatives (hereafter, 'Discharger') and inspected the Brookdale Inn & Spa on July 11, 2012. Based on the lack of response from the Discharger and the abandoned state of the Brookdale Inn & Spa, Water Board staff understands the facility is no longer operational. Brookdale Inn & Spa was once a hotel, spa, and restaurant, owned and operated by the Discharger at 11570 Highway 9, Brookdale, California. The facility is now vacant. The annual permit fee for fiscal years 2008 through 2012 have not been paid by the Discharger and self-monitoring reports have not been submitted since 2008. Water Board staff do not believe the existing Order is being acknowledged by the Discharger.

It is most appropriate to rescind the Discharger's Order No. 01-035 rather than keep it active to accommodate potential similar future land uses and wastewater discharges. Therefore, at a regularly scheduled public meeting **at the Central Coast Regional Water Quality Control Board Office, 895 Aerovista Place, Suite 101, San Luis Obispo, California on January 31, 2013**, we will recommend the Regional Board rescind Order 01-035.
