All:

On Wednesday April 16, 2008, Carl Niizawa, Dale Rosskamp, and I met with Lisa McCann and Matt Thompson from the Regional Board to discuss their review of the City's Storm Water Development Standards and their specific comments on how/where the SWDS fail to comply with the City's Permit and otherwise need improvement. Their review and comments are on the December 31, 2007 version, which has not changed since that submittal. The Regional Board staff's comments, as presented to the City on April 16, 2008, are attached for the Stakeholders' reference.

City staff, working with Kennedy/Jenks Consultants and in continued collaboration with Regional Board staff, will revise the SWDS to address the Regional Board staff's comments (as shown on the attached) and the Stakeholders comments received prior to December 31, 2007. As stated in the Regional Board's earlier letter to the City, the revised SWDS must be submitted to the Regional Board staff no later than May 19, 2008. The City will revise the SWDS and will meet that deadline. As you all may remember, the City's SWDS will be before the Regional Board for consideration on July 11, 2008 in Watsonville.

City staff would like to meet with the Stakeholders Committee to review the revised SWDS. Please check your calendars for availability on Monday May 19, 2008 from 1:00-2:30 for a meeting and let me know if you are available. At this meeting we will discuss the revisions and discuss the schedule for review and comment by the Stakeholders and by the public, generally. I understand it has been some time since we all last met, so if anyone thinks a meeting prior to that date would be productive, please let me know and we can work to schedule a meeting prior to May 19.
