#### WATER QUALITY CERTIFICATIONS

[Dominic Roques 805/542-4780]

In general, staff recommends "Standard Certification" when the applicant proposes adequate mitigation. Measures included in the application must ensure that beneficial uses will be protected, and water quality standards will be met.

Conditional Certification is appropriate when a project may adversely impact surface water quality. Conditions allow the project to proceed under an Army Corps permit, while upholding water quality standards.

Staff will recommend "No Action" when no discharge or adverse impacts are expected. Generally, a project must provide beneficial use and habitat enhancement for no action to be taken by the Regional Board. #### Presentations and Training [Roger Briggs 805/549-3140]

Executive Officer Roger Briggs gave a presentation as part of a panel on stormwater and watershed protection at the American Public Works Association training conference in Salinas on July 22nd. Dr. Darla Inglis, Director of the Central Coast Low Impact Development Center, and Jerry Bunin, Governmental Affairs Director, Central Coast Home Building Association were part of the panel, which was well received by the approximately 90 people in attendance. Roger discussed the draft update of the statewide construction permit, as well as current status and direction of municipal stormwater regulation.
