TERMINATION OF WASTE DISCHARGE REQUIREMENTS

December 12-13, 2019

**FINDINGS**

The Central Coast Regional Water Quality Control Board (Central Coast Water Board) finds that:

1. Waste discharge requirements Order No. R3-2014-0047 (adopted on November 14, 2014), prescribes requirements for the discharge of brine and other wastewaters originating from the Cambria Community Services District's (CCSD) Emergency Water Supply facility to a lined Class II surface impoundment regulated pursuant to title 27 requirements. The CCSD's Class II surface impoundment facility is located in the city of Cambria in San Luis Obispo County. The Class II surface impoundment is no longer operational and has been emptied and cleaned out to the satisfaction of Central Coast Water Board staff. Waste previously discharged to the surface impoundment will now be properly disposed of by trucking the waste to an appropriately regulated facility (e.g., South San Luis Obispo County Sanitation District's wastewater treatment facility).
2. Waste discharge requirements Order No. 03-0054 (adopted on May 16, 2003), prescribes requirements for the disposal of domestic wastewater originating from San Jerardo Cooperative, Inc.'s wastewater treatment plant to unlined evaporation/percolation ponds. San Jerardo Cooperative, Inc. serves a 66-unit farmworker housing community with an average wastewater flow of 25,500 gallons per day. San Jerardo Cooperative, Inc.'s wastewater treatment plant underwent upgrades and now has a lined treatment pond, two evaporation/percolation ponds, and disposes of additional wastewater in an onsite leachfield. On September 24, 2019, the Central Coast Water Board Executive Officer enrolled San Jerardo Cooperative, Inc. in Order WQ 2014-0153-DWQ, a statewide general order that prescribes requirements for small domestic wastewater treatment systems. Order No. 03-0054 is no longer necessary and needs to be terminated to regulate the discharge of waste from the wastewater treatment plant pursuant to the statewide general order.
3. Waste Discharge Requirements Order No. 91-03 (adopted on September 13, 1991), prescribes requirements for the discharge of reclaimed wastewater from the Goleta Sanitary District facility. The facility provides collection, treatment, and disposal of wastewater generated by the community of Goleta (approximately four million gallons per day). On September 28, 2017, the Central Coast Water Board adopted revised requirements for the Goleta Sanitary District Water Resource Recovery facility (NPDES Order No. R3-2017-0021). Goleta Sanitary District's WDR Order No. 91-03 is no longer necessary and can be terminated because NPDES Order No. R3-2017-0021 now

regulates the discharge of reclaimed wastewater.

**IT IS HEREBY ORDERED** that WDR order Nos. R3-2014-0047, 03-0054, and 91-03 are terminated on the date of this Order.
