The presenters, representing the Los Osos Community Services District, Golden State Water Company, San Luis Obispo County, and S&T Mutual Water Company, provided an update on Los Osos Groundwater Basin Management, including:

- Basin Management Plan development
- Current conditions of groundwater pumping and sea water intrusion
- Goals of basin management
- Monitoring and metrics (e.g., water levels and chloride concentrations) to gage achievement of goals

- Strategies to improve conditions including urban water use efficiency, water reinvestment/recharge, changing pumping locations, nitrate removal
- Specific recommendations for programs and projects to implement

Board members asked questions about water use, plan assumptions, financing, timing for basin to show response, and potential actions and authorities the Central Coast Water Board or State Water Resources Control Board can invoke if the basin does not improve. Board members directed staff to attend the first Basin Management Committee meeting, scheduled for December 14. Lisa McCann will attend.

15. San Lorenzo River Bacteria Evaluation – Coastal Watershed Council – Greg Pepping, Executive Officer [Karen Worcester, 805/549-3333 or Karen Worcester@waterboards.ca.gov]

A presentation was given by Greg Pepping, Executive Director, Coastal Watershed Council, on behalf of the San Lorenzo River Alliance.

Greg Pepping provided the following information:

- Background and historical water quality and recreation uses of the San Lorenzo River
- Description of the effective and productive collaborative effort by local agencies and organizations to act as the San Lorenzo River Alliance
- Description and results of bacteria water quality monitoring (human sources are minimal)
- Next steps for pollution identification and elimination

Mr. Pepping further requested that their bacteria study results inform re-evaluation of the numeric targets and load allocations in the Total Maximum Daily Load for Pathogens in San Lorenzo River Watershed and that the Central Coast Water Board support grant funding requests.

He also shared some slides and information depicting the Coastal Watershed Council's outreach and education activities and vision for future recreational use of the lower San Lorenzo River.

Board members expressed support for monitoring and activities to improve conditions in the San Lorenzo River and agreed that the Executive Officer can issue a letter of support.
