ORDER AMENDING NOTICE OF APPLICABILITY FOR COVERAGE UNDER GENERAL ORDER NO. R5- 2020-0048, WASTE DISCHARGE REQUIREMENTS AND CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION OF THE WESTERN PLACER COUNTY HABITAT CONSERVATION PLAN PROGRAMMATIC GENERAL PERMIT; JEN CALIFORNIA 24 LLC, JOINER RANCH EAST PROJECT (WDID#5A31CR00534-002A1), PLACER COUNTY

This Order responds to the 11 January 2024 request for an amendment of the Joiner Ranch East Project (Project) Notice of Applicability (NOA) for coverage under Central Valley Regional Water Quality Control Board (Central Valley Water Board) General Order R5-2020-0048, Waste Discharge Requirements and Clean Water Act Section 401 Water Quality Certification of the Western Placer County Habitat Conservation Plan Programmatic General Permit (WDID#5A31CR00534-002).
