**ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER, PLACER VINEYARDS CENTRAL GROUP, LLC, PLACER VINEYARDS CENTRAL/1A SHARED BASELINE ROAD #02 (INFRASTRUCTURE SEGMENT F) PROJECT (WDID NO. 5A31CR00561A1), PLACER COUNTY**

This Order responds to the 26 August 2022 request for an amendment of the Placer Vineyards Central/1A Shared Baseline Road #02 (Infrastructure Segment F) Project Section 401 Water Quality Certification (WDID No. 5A31CR00561). The original Water Quality Certification (Certification) was issued on 23 December 2021. The requested amendment is hereby approved, and the original Certification is therefore amended as described below. Please attach this document to the original Certification.

**AMENDMENT:**

Placer Vineyards Central Group, LLC is requesting an amendment to the Certification to align the mitigation credit nomenclature in the Certification with the nomenclature currently used in the context of the Placer County Conservation Program (PCCP). Therefore, Section XIV.K.4; Section XIV, Table 3; and Attachment B, Table 4 and Table 5 are amended in underline format below.

**XIV.K. Compensatory Mitigation for Permanent Impacts:**

**4. Total Required Compensatory Mitigation**

- a. The Permittee is required to provide compensatory mitigation for the authorized impact to 0.211 acre of Seasonal Wetland Swale (Curry Creek) through the replacement of a minimum of 0.211 acres of the impacted sections of Curry Creek.
- b. The Permittee is required to provide compensatory mitigation for the authorized impact to 0.077 acre of Seasonal Wetland Swale (Curry Creek) by purchasing 0.116 Riverine/Riparian credits in the Placer County Conservation Program In-Lieu Fee Program.

- c. The Permittee is required to provide compensatory mitigation for the authorized impact to 0.175 acre of Seasonal Wetland Swale by purchasing 0.262 Vernal Pool Complex credits in the Placer County Conservation Program In-Lieu Fee Program.
- d. The Permittee is required to provide compensatory mitigation for the authorized impact to 0.089 acre of Vernal Pools by purchasing 0.134 Vernal Pool credits in the Placer County Conservation Program In-Lieu Fee Program.
- e. Total required Project compensatory mitigation information for permanent physical loss of area is summarized in Table 3. [Establishment (Est.), Re-establishment (Re-est.), Rehabilitation (Reh.), Enhancement (Enh.), Preservation (Pres.), Unknown].
