ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; L STREET LAND L.P. AND BVRP L.P., NORTHBOROUGH PROJECT (WDID#5A34CR00749A4), SACRAMENTO COUNTY

This Order responds to the 24 January 2024 request for an amendment of the Northborough Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00749). The original Water Quality Certification (Certification) was issued on 1 February 2019, amended on 23 September 2019 (WDID#5A34CR00749A1), amended on 30 July 2021 (WDID#5A34CR00749A2), and amended on 18 March 2022 (WDID#5A34CR00749A3). The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

L Street Land, L.P. and BVRP L.P. are requesting an address change and time extension through 13 May 2024. The new address for L Street Land L.P. and BVRP L.P. is as follows:

No fee was required for this amendment. Total fees of \$1,500.00 for the original Certification were received on 8 August 2018. The remaining fee balance of \$109,022.00 based on total Project impacts was received on 11 December 2018. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
