### **ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; SACRAMENTO COUNTY DEPARTMENT OF TRANSPORTATION, DILLARD ROAD BRIDGE SCOUR CRITICAL PROJECT (WDID#5A34CR00769), SACRAMENTO COUNTY**

This Order responds to the 31 October 2022 request for an amendment of the Dillard Road Bridge Scour Critical Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00769). The original Water Quality Certification (Certification) was issued on 23 August 2019. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

#### **AMENDMENT:**

Sacramento County Department of Transportation is requesting a time extension through 26 March 2026. A time extension was authorized by the United States Army Corps of Engineers on 19 January 2023.

Sacramento County Department of Transportation has provided documentation from the United States Army Corps of Engineers (SPK-2015-00570) authorizing in-water construction activities to continue until 26 March 2026.

The Certification is amended to extend the expiration date of the authorization to 26 March 2026.

#### **APPLICATION FEE RECEIVED:**

No fee was required for this amendment. Total fees of \$7,389.00 for the original Certification were received on 5 June 2019. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
