Notice of Termination for General Order No. R5-2008-0149-023, Former JCPenney Store No. 5380, 6939 65th Street, Sacramento, Sacramento County

On 28 March 2011, the Executive Officer of the Central Valley Regional Water Quality Control Board issued a Notice of Applicability under Order No. R5-2008-0149, *In-Situ Groundwater Remediation at Sites with Volatile Organic Compounds, Nitrogen Compounds, Perchlorate, Pesticides, Semi-Volatile Compounds, Hexavalent Chromium and/or Petroleum Hydrocarbons.* In the Notice of Applicability, the project was assigned site-specific Order No. R5-2008-0149-023. A revised Monitoring and Reporting Program was issued on 1 April 2015.

Injection of ozone stopped in June 2013 due high backpressure in several of the injection wells, and due to detections of hexavalent chromium in groundwater samples. The injection system is currently and will continue to be used for air injection only.

Your consultant, AECOM, requested termination of coverage for the Project on your behalf in an email dated 5 May 2017. Therefore, through this letter, General Order No. R5-2008-0149-023 and Monitoring and Reporting Program No. R5-2008-0149-023-R are hereby terminated as of the date of this letter. Invoicing for General Order coverage will be terminated accordingly.
