MINOR MODIFICATION, WASTE DISCHARGE REQUIREMENTS ORDER R5-2016-0076 (NPDES PERMIT NO. CAG995002) FOR LIMITED THREAT DISCHARGES TO SURFACE WATER

On 14 October 2016 the Central Valley Regional Water Quality Control Board (Central Valley Board) adopted Order R5-2016-0076 (NPDES Permit CAG995002) for Limited Threat Discharges to Surface Water (Limited Threat General Order). The below typographical errors in the Limited Threat General Order were noted by staff. Pursuant to Code of Federal Regulations, 40 CFR section 122.63(a), minor modification of an NPDES permit is allowed to correct typographical errors. The following minor modification, shown in underline/strikeout format, is made to the Limited Threat General Order, section Il.B.2, paragraph one, to correctly identify and clarify the required due date for submittal of the Notice of Intent.

Existing Discharges.

Current enrollees authorized to discharge under the existing Limited Threat General Order R5-2013-0073-01 (NPDES Permit No. CAG995002) are automatically authorized under this General Order to continue discharging. However to maintain general order coverage, the current enrollees must submit a complete Notice of Intent (NOI), as described in sections II.A.1.a through h, above, and in Attachment J, within 90180 days of the adoption of this Order, to adequately characterize the discharge for coverage under this Order.

Additionally, the Fact Sheet, Attachment D of the Limited Threat General Order, section Ill.A.7.b, paragraph one, is updated to correctly identify and clarify the required due date for submittal of the Notice of Intent. The correction is shown in underline/strikeout format.

Existing Discharges. Current enrollees authorized to discharge under the existing Limited Threat General Order R5-2013-0073-01 (NPDES Permit No. CAG995002) are automatically authorized under this General Order to continue discharging. However to maintain general order coverage, the current enrollees must submit a complete Notice of Intent (NOI), as described in sections II.A.1.a through h, above, and in Attachment J, within 180 days of the adoption effective date of this Order, to adequately characterize the discharge for coverage under this Order.
