TENTATIVE CEASE AND DESIST ORDER CITY OF AUBURN WASTEWATER TREATMENT PLANT PLACER COUNTY

TO ALL CONCERNED PERSONS AND AGENCIES:

Enclosed is a tentative Cease and Desist Order CDO proposing to replace existing CDO No. R5-2005-0031 for the City of Auburn Wastewater Treatment Plant. The tentative CDO proposes to extend the compliance schedules for aluminum, chloroform, copper, dibromochloromethane, dichlorobromomethane, nickel, nitrites, nitrate-plus-nitrite, silver and zinc currently regulated by Waste Discharge Requirements Order No. R5-2005-0030. The tentative CDO has been publicly noticed for a hearing at the January 2008 Regional Water Quality Control Board (Regional Water Board) Meeting. Any comments you may have regarding the enclosed document must be submitted to the Regional Water Board office by 12:00 p.m. (noon) on **13 December 2007** to be given full consideration prior to the January 2008 Regional Water Board meeting. Comments submitted after 12:00 p.m. (noon) on **13 December 2007** may not be considered.
