NOTICE OF PUBLIC HEARING
concerning

TENTATIVE REVISED WASTE DISCHARGE REQUIREMENTS
FOR
COUNTY OF TUOLUMNE
JAMESTOWN LANDFILL
CLOSURE, POST-CLOSURE MAINTENANCE, AND CORRECTIVE ACTION
TUOLUMNE COUNTY

The County of Tuolumne owns and operates the Jamestown Road Landfill located near Jamestown. At the direction of the Regional Water Board, the County requested a revision of the waste discharge requirements (WDRs) for approval of re-closure of the landfill. The proposed WDRs approve the components of the final cover and other basic design parameters for re-closing the landfill. The existing final cover was completed in 2005. The final cover has and is continuing to fail due to desiccation of the clay layer, and slope and erosion failure due to the steepness of the side slopes. The proposed re-closure of the landfill includes reduction of side slope steepness, currently as steep as 1.4 horizontal to 1 vertical, to no steeper than 2.75 horizontal to 1 vertical, and construction of benches. Waste will be relocated from the side slopes to the top deck, and the new final cover will include a geomembrane layer instead of clay. New landfill gas vents will also be installed. The proposed tentative WDRs require completion of re-closure of the landfill during 2008. Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **30 May 2008**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Regional Water Board no later than **30 May 2008**. Written evidence or comments submitted after **30 May 2008** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
