RESCINDING WASTE DISCHARGE/NPDES RESCISSIONS

The California Regional Water Quality Control Board, Central Valley Region, finds that the Board adopted the following Orders which are no longer applicable for the reasons shown:

IT IS HEREBY ORDERED that the above NPDES/WDR orders are rescinded.

- a) Waste Discharge Requirements (WDR) Order No. 96-136 was adopted on 3 May 1996 for Jeff Wilson, dba Belden Town Resort and Ivan Coffman, for their resort near the North Fork of the Feather River. The resort consists of a tavern, store, café, and approximately 40 dwelling units, including cabins and RV spaces. Ivan Coffman is now the sole owner of the Resort. The discharger plans to add 4 units to an existing motel, and finish construction on 15 units in the motel, as well as removing approximately 10 RV sites from service. The flow from the resort was never known precisely; it is estimated the upgrades to the facility (motel rooms), minus the RV space removal., will result in an increase in flow of approximately 0.001 mgd, raising the total flow to approximately 0.009 mgd. The Discharger will install all new disposal fields for the existing and new flows. The discharger has recently been enrolled in the State Water Resources Control Board Water Quality Order No. 97-10-DWQ, General Waste Discharge Requirements for Discharges to Land by Small Domestic Wastewater Treatment Systems. Order No. 93-136 is therefore no longer necessary and should be rescinded. (RSD)
- b) Harter Packing Company, Tut Brothers Farms LLC, and LOMO Cold Storage, A California General Partnership, Richland Ranches LTD of California a California Corporation, and Harter Tomato Products Company, Sutter County Order No. 5-00-252, adopted 27 October 2000, prescribes requirements on Harter Packing Company, Tut Brothers Farms LLC, and LOMO Cold Storage, A California General Partnership, Richland Ranches LTD of California a California Corporation, and Harter Tomato Products Company for the permitted discharge of tomato processing wastewater to land application areas associated with the tomato processing facility at 1321 Harter Road, Sutter County. Wastewater discharge ceased in 2002 at the site; much of the area has been redeveloped as retail commercial developments. The area is now served with treated surface water for drinking water supply and a sewer collection system. Therefore, it is appropriate to rescind the Waste Discharge Requirements. (TRO)
- c) Waste Discharge Requirements (WDRs) Order No. R5-2004-0150 (NPDES Permit No. CA0080373), adopted on 15 October 2004, prescribes waste discharge requirements for Mt. Lassen Trout Farms Inc. and Fred and Nancy Cline for the Meadowbrook Facility for discharge of flow-through aquaculture operations water to Paynes Creek, a water of the United States, Tehama County. The facility ceased all aquaculture activities in June 2009. All fish have been removed from the facility and the raceways and settling ponds have all been cleaned. The Discharger has asked that the WDRs be rescinded.

Therefore it is appropriate to rescind the WDRs. (GDC)

- d) Waste Discharge Requirements Order No. R5-2007-0169 (NPDES Permit No. CA0080853) prescribes requirements for discharges from the Chevron U.S.A. Inc. (Chevron), crude oil production and treatment facility, to the City of Bakersfield's and the Kern Delta Water District's Carrier Canal, a water of the United States within the Kern Hydrologic Unit (No. 557.10). The treatment facility consists of mechanical separation, sedimentation, filtration, and air floatation. Chevron's agreement with the City of Bakersfield and the Kern Delta Water District to discharge to the Carrier Canal expired on 30 June 2009. Chevron does not intend to extend the agreement and has requested rescission of Order No. R5-2007-0169. Chevron maintains the ability to discharge the treated produced water to the Cawelo Water District's Reservoir B under Order No. R5-2007-0170. (AMO)
- e) Waste Discharge Requirements (WDRs) Order No. R5-2008-0064, adopted on 25 April 2008, prescribes requirements for the BP West Coast Products, ARCO/BP Stockton, Terminal #40T at 2700 West Washington Street in the Port of Stockton, San Joaquin County. The Discharger proposed to inject chemicals into the subsurface to conduct an enhanced bioremediation pilot study. The Discharger subsequently decided not to conduct the pilot study and requested that Order No. R5-2008-0064 be rescinded.
