**NOTICE OF PUBLIC HEARING**

SACRAMENTO REGIONAL WASTEWATER TREATMENT PLANT  
SACRAMENTO COUNTY**

Sacramento Regional County Sanitation District (Discharger) owns and operates the Sacramento Regional Wastewater Treatment Plant. The Discharger provides wastewater treatment service to the Cities of Sacramento, Folsom, West Sacramento, and the Sacramento Area Sewer District. The Sacramento Area Sewer District service area includes the Cities of Elk Grove, Rancho Cordova, Citrus Heights, and portions of the unincorporated areas of Sacramento County. The population served is approximately 1.3 million people. The treatment plant is permitted to discharge 181 million gallons per day of treated wastewater to the Sacramento River within the Sacramento-San Joaquin Delta.

On 9 December 2010, the Central Valley Water Board adopted Waste Discharge Requirements Order R5-2010-0114 and Time Schedule Order (TSO) R5-2010-0115 prescribing waste discharge requirements for the Sacramento Regional Wastewater Treatment Plant. An order is proposed to correct and clarify the Orders, which includes, in part, modifications to the Monitoring and Reporting Program, allows use of recycled disinfected secondary effluent at the wastewater treatment plant, increases the effluent limitation for manganese, and adds an interim limitation for diazinon in the TSO.

A public hearing concerning this matter will be held during the Central Valley Regional Water Quality Control Board (Central Valley Water Board) meeting, which is scheduled for:

The designated parties for this hearing are as follows:

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as

a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 17 October 2011**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than **5:00 p.m. on 17 October 2011**. Written evidence or comments submitted after **5:00 p.m. on 17 October 2011** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
