Hi Mary,

I am currently drafting a letter that clarifies issues raised by the your letter of 2/16/2012 and that follows up on RBI's submission of the Addendum. I will be sure to attach both a hard copy of the addendum and a cover letter from Jeff Butzlaff that simply notes the City is formally submitting (1) the Addendum from RBI and (2) a letter from the City Attorney regarding regulatory compliance. I will ensure that Jeff Butzlaff's cover letter contains the certification statement.

In better news, the City Council has asked that we agendize Winzler & Kelly's contract for the alternatives analysis, the sampling plan and testing of Ponds 5 and 6, and the SRF application for the March 20, 2012 meeting. Additionally, we hold out some hope that RBI may still be persuaded to draft the RWD either directly as a City consultant or as a sub-consultant for Winzler & Kelly. We hope to resolve that issue as well at the City's March 20, 2012 City Council meeting.

The recall election failed with by a 64% to 36% margin and staff believes that the lone City Council is again committed to moving this project forward as expeditiously as possible.
