**NOTICE OF PUBLIC HEARING**

**RENEWAL OF WASTE DISCHARGE REQUIREMENTS  
(NPDES PERMIT NO. CA0085129)**

For  
**AMERIPRIDE SERVICES INC.  
OPERABLE UNIT 3  
SACRAMENTO COUNTY**

AmeriPride Services, Inc. (Discharger) is the owner and operator of the Operable Unit 3 (Facility), a groundwater extraction and treatment system located at 8450 Gerber Road, Sacramento, California. The Discharger operates an industrial laundry facility at 7620 Wilbur Way, Sacramento, California. Dry cleaning operations on the Discharger's property by the previous owner led to releases of tetrachloroethylene, which have impacted both soil and groundwater. The impacted groundwater extends east from the Discharger's property to neighboring properties. The property on which the Facility is located is owned by Huhtamaki Food Service, Inc. The Facility consists of two granulated activated carbon vessels, operated in series, and is designed to treat up to 300 gallons per minute of contaminated groundwater. Treated groundwater is discharged via an unnamed storm water ditch to Beacon Creek, a water of the United States, and tributary to the Sacramento River via Morrison Creek.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2007-0079, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 22 June 2007. An Order is proposed to renew the NPDES permit.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 6 August 2012**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than **5:00 p.m.** on **6 August 2012**. Written evidence or comments submitted after **5:00 p.m.** on **6 August 2012** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
