**NOTICE OF PUBLIC HEARING**

WASTEWATER TREATMENT PLANT  
CALAVERAS COUNTY**

The City of Angels is the owner and operator of the City of Angels Wastewater Treatment Plant (Facility), located at 3000 Centennial Road, Angels Camp, California. The Facility provides sewerage service for the City of Angels. Tertiary treated wastewater from the Facility is discharged to a 66 million gallon storage reservoir where it is used for spray irrigation on 61 acres of pastureland. During the irrigation season, effluent may also be reclaimed on 110 acres of the Greenhorn Creek Golf Course. When wastewater flows exceed the land disposal and storage capacity of the Facility, treated wastewater may be discharged seasonally from 15 November to 15 May to Angels Creek, a water of the United States, and a tributary to New Melones Reservoir and the Stanislaus River.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2007-0031-01, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 3 May 2007 and amended by Order R5-2009-0074 on 13 August 2009. An Order is proposed to renew the NPDES permit.
