TENTATIVE RESCISSION OF CEASE AND DESIST ORDER NO. R5-2010-0064 FOR CITY OF MT. SHASTA AND U.S. DEPARTMENT OF AGRICULTURE, FOREST SERVICE, CITY OF MT. SHASTA WASTEWATER TREATMENT PLANT, SISKIYOU COUNTY

TO ALL CONCERNED PERSONS AND AGENCIES:

Enclosed is a tentative Order to rescind Cease and Desist Order No. R5-2010-0064 for the City of Mt. Shasta and U.S. Department of Agriculture, Forest Service, City of Mt. Shasta Wastewater Treatment Plant in Siskiyou County. To be given full consideration, any comments or recommendations you may have concerning the tentative Orders must be submitted in writing to the Central Valley Regional Water Quality Control Board (Central Valley Water Board) office by **5:00 pm on 30 August 2013**. Written materials submitted after this date and time will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party. Please note that the tentative documents will receive internal legal and management review during the public comment period.

A Public Hearing has been scheduled for the Central Valley Water Board to consider adoption of the tentative Order at its **3, 4 October 2013 Board Meeting**. The Notice of Public Hearing (4 copies) and a copy of a Proof of Posting form are also enclosed. **By 2 August 2013** post one (1) copy of the Notice of Public Hearing at:

- The entrance to the facility;
- The nearest city hall or county courthouse; and
- The post office nearest to the Facility (if allowed).

Proof of posting, using the enclosed form, shall be filed with this office by **9 August 2013**.
