Tentative Waste Discharge Requirements (WDRs)/NPDES permit and a tentative Time Schedule Order (TSO) for the Mariposa Public Utility District, Wastewater Treatment Facility are available for public comment, as explained in the enclosed Notice of Public Hearing. To conserve resources, paper copies of the tentative WDRs/NPDES permit and tentative TSO are being sent to the Discharger only. The tentative WDRs/NPDES permit, tentative TSO, and any additional information are available electronically on the Central Valley Regional Water Quality Control Board's (Central Valley Water Board) web site at:

The Central Valley Water Board has not reviewed or made any decision concerning the tentative WDRs/NPDES permit and tentative TSO, which may still be revised following the comment period. Revised documents along with comments and the staff responses will be posted on the above web site and placed in the Central Valley Water Board meeting agenda. The Central Valley Water Board will consider these and any appropriate oral testimony at the scheduled public hearing. The Central Valley Water Board may elect to adopt WDRs/NPDES permit or a TSO that differ from the recommended WDRs/NPDES permit and TSO and may do so without another public comment period if determined to be consistent with applicable laws and regulations.
