Thank you for your time this morning. This will serve to acknowledge receipt of the complaint and subpoena package as requested. I will confer with Mr. Sheehan's counsel Mr. Steffan as to previous Board correspondence and responses. I am checking on client availability for an initial settlement meeting next week. As you know I am waiting to hear back from Mr. Sellens and will advise you accordingly.

When we meet, among other things will be an enumeration of the outstanding tests and reports presently required to obtain an understanding of site conditions. I will ask Mr. Sellens to also undertake review and

development of recommendations for the discharger's consideration.

Also as we discussed, my communications will be directed through you as counsel to the Board to adhere to the protocols of represented parties even though I understand that members of Board staff may communicate directly. We did not discuss it but, may I request, until further notice, that all Board contact be through my office as counsel for the discharger, A Greener Globe, Inc. given that the matter finds itself before the Board as an enforcement action.
