### **NOTICE OF TENTATIVE WASTE DISCHARGE REQUIREMENTS FOR PORT OF STOCKTON DENMAR NATURAL SODA ASH EXPORT TERMINAL PROJECT, SAN JOAQUIN COUNTY**

#### **TO ALL CONCERNED PERSONS AND AGENCIES:**

Enclosed are tentative Waste Discharge Requirements for the Denmar Natural Soda Ash Export Terminal Project (Project) in San Joaquin County.

The 101-acre Project will remediate soils to address historical contamination areas within the site and develop a soda ash export terminal. Several wetland areas are in and near contaminated areas that will require remediation of hazardous substances in soils through excavation or capping.

A public hearing concerning this matter will be held during the Central Valley Regional Water Quality Control Board (Central Valley Water Board) meeting scheduled for:

PLACE: Remote Meeting via Video Teleconference
