### RESPONSE TO COMMENTS REGARDING TENTATIVE RESCISSION OF WASTE DISCHARGE REQUIREMENTS, FORESTHILL LANDFILL, PLACER COUNTY

The attached document notes written comments received by the Central Valley Regional Water Quality Control Board from interested persons regarding the tentative Rescission of Waste Discharge Requirements (WDRs) for the closed Foresthill Landfill in Placer County circulated on 28 September 2022. Written comments were required by public notice to be received by the Central Valley Water Board by 28 October 2022 to receive full consideration.

The Central Valley Water Board staff also made minor changes to the tentative Rescission Order to improve clarity and fix typographical errors. A public hearing concerning this matter will be held during the Central Valley Water Board meeting scheduled for 8/9 December 2022 at 8:30 a.m. via video and teleconference, and/or in-person meeting at the Cal/EPA Headquarters Building at 1001 I Street, Costal Hearing Room, Second Floor, Sacramento, California, 95814 pending changes in pandemic restrictions.
