**ORDER R5-2023-XXXX**

**RESCINDING WASTE DISCHARGE REQUIREMENTS**

The California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board), finds that the Central Valley Water Board adopted the following Orders which are no longer applicable for the reasons shown:

**A) THE BOEING COMPANY, GROUNDWATER EXTRACTION AND TREATMENT SYSTEMS GET HB, SOUTHERN GROUNDWATER STUDY AREA GET, AND ADMIN GET, SACRAMENTO COUNTY, ORDER NO. R5-2017-0096 (NPDES PERMIT CA0084891)**

Waste Discharge Requirements Order R5-2017-0096 (NPDES Permit CA0084891) adopted on 11 August 2017 prescribed requirements for the Boeing Company Groundwater Extraction And Treatment Systems GET HB, Southern Groundwater Study Area GET, and Admin GET (Facilities) in Sacramento County. Order R5-2017-0096 authorized discharge of treated groundwater from both facilities to Morrison Creek, tributaries to the Sacramento River. On 15 April 2022, the Boeing Company submitted a Report of Waste Discharge in accordance with its existing individual National Pollutant Discharge Elimination System (NPDES) permit. Based on the Report of Waste Discharge and subsequent information submitted by the Discharger, staff determined that the Facilities are eligible for coverage under the *General Waste Discharge Requirements for Limited Threat Discharges To Surface Water, Order R5-2022-0006-01* (Limited Threat General Order). The Central Valley Water Board's Executive Officer issued a Notice of Applicability (R5-2022-0006-017) with an effective date of **1 July 2023**. Since regulatory coverage for the discharge of treated wastewater to surface water will be provided under the Limited Threat General Order, individual Order R5-2017-0096 is no longer necessary and is appropriate to rescind, effective 1 July 2023.

**B) CITY OF LATHROP, LATHROP CONSOLIDATED TREATMENT FACILITY, SAN JOAQUIN COUNTY, WASTE DISCHARGE REQUIREMENTS ORDER NO. R5-2016-0028-01**

Waste Discharge Requirements Order No. R5-2016-0028, adopted on 21 April 2016 and amended on 6 April 2018 (R5-2016-0068-01), prescribes requirements for the Lathrop Consolidated Treatment Facility in San Joaquin County. The Discharger is ceasing discharges of wastewater to land to maximize the beneficial use of recycled water mainly through landscape irrigation and construction uses. The remaining effluent will be discharged via the surface water outfall to the San Joaquin River. The distribution and use of recycled water is regulated under the State Water Resources Control Board Order No. WQ 2016-0068-DDW-R5017; therefore, it is appropriate to rescind WDRs Order No. R5-2016-0068-01 and the corresponding Monitoring and Reporting Program (MRP) Order No. R5-2016-0068-02.

**C) COUNTY OF MARIPOSA, COULTERVILLE WASTEWATER TREATMENT FACILITY, WASTE DISCHARGE REQUIREMENTS ORDER NO. 5-00-193, MARIPOSA COUNTY**

Waste Discharge Requirements Order 5-00-193, adopted on 4 August 2000, prescribes requirements for the discharge from the County of Mariposa, Coulterville Wastewater Treatment Facility (Facility). The Facility features an advanced primary treatment system and discharges to a storage/settling pond followed by two spray fields. On 28 August 2020, County of Mariposa submitted a Form 200 and Report of Waste Discharge for coverage under State Water Resources Control Board Order 2014-0153-DWQ, *General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems* (General Order) for the Facility. On 16 March 2023, a Notice of Applicability was issued for the Facility (enrollee number 2014-0153-DWQ-R5388) enrolling the Facility under the General Order upon rescission of Order 5-00-193. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 5-00-193.

**D) JOHNSVILLE PUBLIC UTILITY DISTRICT, PLUMAS COUNTY, ORDER R5-2002-0144**

Waste Discharge Requirements Order R5-2002-0144, adopted on 19 July 2002, prescribes requirements for waste discharge from Johnsville Public Utility District (Discharger) potable water treatment facilities (Facility). The Discharger discharges filter backwash wastewater to an onsite pond. The Discharger has been enrolled under the Central Valley Water Board's Low-Threat Waiver R5-2018-0085. Therefore, it is appropriate to rescind Waste Discharge Requirements Order R5-2002-0144.

**E) R WILD HORSE RANCH, TEHAMA COUNTY, ORDER 85-102**

Waste Discharge Requirements Order 85-102, adopted on 31 May 1985, prescribes requirements for the discharge from R-Wild Horse Ranch wastewater treatment and disposal system, Tehama County (Facility). The Facility is comprised of a wastewater collection system, septic tanks, and nine treatment and disposal ponds. The Facility is now regulated under Water Quality Order 2014-0153-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 100,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 85-102.

**F) SHASTA RANCH AGGREGATE, SHASTA COUNTY, ORDER R5-2007-0177**

Waste Discharge Requirements Order R5-2007-0177, adopted on 6 December 2007, prescribes requirements for waste discharge from Shasta Ranch Aggregate, Tullis Inc. and Shasta Ranch Estates, LLC (Discharger) sand and gravel (aggregate) mining and processing facilities (Facility). The Discharger previously discharged process water to onsite ponds. The Discharger has ceased aggregate extraction and processing at the site with no intent to resume operations. Processing equipment has been removed from the site for reclamation activities to begin. The Reclamation Plan Amendment is under review by Shasta County Planning Department at the

time. The Discharger requested rescission of the permit. Therefore, it is appropriate to rescind Waste Discharge Requirements Order R5-2007-0177.

**G) THOUSAND TRAILS, INC., DONNER PASS RECREATIONAL VEHICLE CAMPGROUND, PLACER AND NEVADA COUNTIES, WASTE DISCHARGE REQUIREMENTS ORDER NO. 96-016**

Waste Discharge Requirements Order No. 96-016 adopted on 26 January 1996 prescribes requirements for the Donner Pass Recreational Vehicle (RV) Campground, now known as Sun NG Cisco Grove RV (Facility) in Nevada and Placer Counties. On 28 October 2022, Sun NG Cisco Grove RV LLC submitted a Report of Waste Discharge requesting coverage under the Statewide General Water Quality Order 2014-0153-DWQ for Small Domestic Wastewater Treatment Systems. Regulation of the discharge was transferred to enrollment under WQ 2014-0153-DWQ-R5365, which was issued by the Executive Officer on 20 April 2023. Therefore, it is appropriate to rescind Order 96-016.

**H) VALLEY SPRINGS PUBLIC UTILITY DISTRICT, VALLEY SPRINGS WASTEWATER TREATMENT PLANT, CALAVERAS COUNTY, WASTE DISCHARGE REQUIREMENTS ORDER R5-2005-0066**

Waste Discharge Requirements Order R5-2005-0066, adopted on 29 April 2005, prescribes requirements for Valley Springs Wastewater Treatment Plant in Calaveras County. On 19 February 2021, the Valley Springs Public Utility District submitted a request to obtain coverage under the Statewide General Order 2014-0153-DWQ for Small Domestic Wastewater Treatment Systems. Regulation of the discharge was transferred to enrollment under General Order WQ 2014-0153-DWQ-R5378, which was issued by the Executive Officer on 28 April 2023. Therefore, it is appropriate to rescind Order R5-2005-0066.

**I) WEIMAR INSTITUTE, INC., WEIMAR INSTITUTE WASTEWATER TREATMENT FACILITY, PLACER COUNTY, WASTE DISCHARGE REQUIREMENTS ORDER NO. R5-2005-0099.**

Waste Discharge Requirements Order R5-2005-0099 adopted on 24 June 2005 prescribes requirements for the Weimar Institute Wastewater Treatment Facility (Facility) in Placer County. On 07 May 2021, Weimar Institute Inc., owner and operator of the Facility, submitted a Report of Waste Discharge (RWD) requesting coverage under the Statewide General Water Quality Order 2014-0153-DWQ for Small Domestic Wastewater Treatment Systems. Regulation of the discharge was transferred to enrollment under WQ 2014-0153-DWQ-R5366, which was issued by the Executive Officer on 28 April 2023. Therefore, it is appropriate to rescind Order R5-2005-0099.

**IT IS HEREBY ORDERED** that the above Orders are rescinded on the date of this order unless otherwise stated above.
