RESOLUTION NO. 83-23

ADOPTING A LIST
OF PRIORITY WATER QUALITY ISSUES
IN FULFILLMENT OF THE TRIENNIAL REVIEW
OF ITS WATER QUALITY CONTROL PLANS AND AMENDMENTS THERETO

WHEREAS, The California Regional Water Quality Control Board, Colorado River Basin Region, adopted Water Quality Control Plans for the West (7A) and the East (7B) Colorado River Basin Region in April, 1975. Subsequently, the Regional Board adopted various amendments to its 1975 Plans.


2. The Regional Board, is responsible for reviewing water quality standards and implementation plans and as appropriate, modifying and adopting standards contained in the Plans under provisions set forth in Sections 303 (c), (d), and (e) of the Federal Clean Water Act, and in Section 13240, Division 7 of the California Water Code.
3. The Regional Board, conducted public hearings on September 22 and November 17, 1982, for the purpose of soliciting advice and input regarding review of its plans; and in identifying water quality issues that may need further investigation.
4. The Regional Board, considered all appropriate public comments and identified the following list of priority water quality issues that require further investigation.
 - . Water quality considerations related to ground waters within the Region
 - . Potential water quality problems from geothermal developments
 - . Establishment of water quality objectives and/or best management practices for pesticides in surface waters
 - . Salton Sea Salinity
5. The Regional Board, is in the process of revising and combining its existing (1975) Plans for the West and East Basin into one document; now

THEREFORE, BE IT RESOLVED that the California Regional Water Quality Control Board, Colorado River Basin Region, in fulfillment of the requirements of Sections 303 (c), (d), and (e) of the Federal Clean Water Act, and Section 13240, Division 7 of the California Water Code, has identified in No. 4 above, priority water quality issues that require further investigation; and hereby establishes the following time schedule for combining and updating its 1975 West and East Colorado River Basin Plans into one document:

- April 15, 1983 - Draft combined Plan mailed for public comments.
- July 13, 1983 - Public Hearing on combined Plan
- August 12, 1983 - Response to public comments and finalization of the combined Plan
- Sept. 21, 1983 - Consideration of adoption of the combined Plan.
