RESOLUTION R7-2012-0046

APPROVING THE INITIAL STUDY AND ADOPTING A NEGATIVE DECLARATION  
FOR  
CONDITIONAL WAIVER OF WASTE DISCHARGE REQUIREMENTS  
FOR  
AGRICULTURAL WASTEWATER DISCHARGES AND DISCHARGES OF WASTES  
FROM DRAIN OPERATION AND MAINTENANCE ACTIVITIES ORIGINATING  
WITHIN  
THE PALO VERDE VALLEY AND PALO VERDE MESA

**WHEREAS**, the California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) finds that:

1. The Regional Water Board proposes to adopt a Conditional Waiver of Waste Discharge Requirements for Agricultural Wastewater Discharges and Discharges of Wastes from Drain Operation and Maintenance Activities Originating within the Palo Verde Valley and Palo Verde Mesa (Conditional Waiver).
2. The Regional Water Board is the lead agency for the subject Conditional Waiver project under the California Environmental Quality Act (CEQA) (Pub. Resources Code, § 21000 et seq.). In that role, the Regional Water Board conducted an Initial Study in accordance with the requirements specified in Section 15063 of the “State CEQA Guidelines” (Cal. Code Regs., Tit. 14, § 15000 et seq.) to evaluate whether the Conditional Waiver could have a significant effect on the environment.
3. Regional Water Board staff’s preliminary determination, based on that Initial Study, is that the proposed project could not have a significant effect on the environment, and therefore, no alternatives or mitigation measures are proposed.
4. On August 8, 2012, the Regional Water Board notified interested agencies and persons of its Intent to Adopt a Negative Declaration for the proposed Conditional Waiver and provided them with an opportunity to submit comments during a public comment period that ended September 10, 2012.
5. On August 23, 2012, the Regional Water Board held a public workshop in Blythe, California, regarding the proposed Conditional Waiver, and considered all testimony and evidence received at the workshop.
6. On September 20, 2012, the Regional Water Board, in a public hearing, considered all comments concerning the discharge to be regulated by the Conditional Waiver and the proposed Negative Declaration.

7. The Regional Water Board finds, on the basis of the whole record before it, which includes the proposed Conditional Waiver, the Staff Report prepared in support of the Conditional Waiver, public comments received, Board staff's responses to public comments, the Initial Study, and Board staff's preliminary environmental impact determination, that there is no substantial evidence that the proposed Conditional Waiver will have a significant effect on the environment, and that the proposed Negative Declaration reflects the Regional Water Board's independent judgment and analysis.

**THEREFORE, BE IT RESOLVED that the Regional Water Board:**

1. Approves the Initial Study and adopts the proposed Negative Declaration for the proposed Conditional Waiver of Waste Discharge Requirements for Agricultural Wastewater Discharges and Discharges of Wastes from Drain Operation and Maintenance Activities Originating within the Palo Verde Valley and Palo Verde Mesa.
2. Directs that a copy of this Resolution be forwarded to the State Water Resources Control Board.
3. Directs that a copy of this Resolution be forwarded to all interested parties.
4. Directs the Executive Officer to file a Notice of Determination with the Office of Planning and Research, State Clearinghouse, pursuant to Public Resources Code Section 21108 and Title 14, California Code of Regulations, Section 15075(a), which is to be accompanied by a check made payable to the California Department of Fish and Game for its current CEQA filing fee of \$2,101.50 for Negative Declarations.
