Groundwater Aquifers with elevated nitrate concentrations

The table below lists groundwater aquifers with public supply wells that have recorded Nitrate concentrations exceeding the Maximum Contaminant Limit of 10 mg/L. Reviewed data came from monitoring results posted on Geotracker GAMA for the period of July 2007 – July 2017. This list is based on limited data, not taking into account private drinking wells, which do not appear in GAMA, or wells where groundwater is not used for municipal supply.


