6. Bard Valley Agricultural General Order Workshop [Logan Raub, ES]

The Board held a public workshop discussing the draft General Waste Discharge Requirements for Discharges of Wastes from Irrigated Agricultural Lands for Dischargers that are Members of a Coalition Group in Bard Valley (Bard Agricultural General Order).

Logan Raub, an Environmental Scientist with the Regional Water Board, gave an overview of the expired Bard Agricultural Conditional Waiver as well as the proposed Bard Agricultural General Order. He provided details about requirements for the coalition and coalition members, and also described the difference between the proposed order and the expired waiver. Stakeholders were given an opportunity to present their comments and concerns during the workshop.

7. Colorado River Basin Water Board Executive Officer's Report [Paula Rasmussen]

Paula Rasmussen reported that the Regional Water Board was now fully staffed with a recent hire of returning staff member Jay Mirpour, Water Resources Control Engineer.

She noted that she and Board Chair Nancy Wright attended a Chair's Meeting in Sacramento which was very interesting and provided valuable information. She and Chair Wright also attended a community forum with the International Boundary and Water Commission (IBWC). At the meeting, Bruce Wilcox, the Natural Resources Agency's (CNRA) Assistant Secretary of Salton Sea Policy, provided an update on the CNRA's activities at the Salton Sea. Additionally, Ms. Rasmussen shared that Regional Water Board staff participated in an educational forum held at California State University San Bernardino campus. The purpose was to introduce middle school and high school students to environmental issues, and various agencies participated in the forum. Board staff also hosted an information table at this event.

The draft bill contains a history of the New River and mentions the Colorado River Basin Water Board, and would task the U.S. Environmental Protection Agency with creating a new program to assist with projects, plans, and initiatives for the New River.
