## 1. Approval of Minutes

3. <u>R7-2019-0019-02</u> – Consideration of adoption of Amended Cease and Desist Order for the Palm Springs Aerial Tramway, Mountain Station Wastewater Treatment Plant, owned and operated by the Mt. San Jacinto Winter Park Authority, located in Palm Springs, Riverside County [*Reginald Tan, WRCE*]

Motion: Ed Muzik moved, Jayne Powell seconded, and a roll call vote was taken.

The motion was carried unanimously to adopt Order R7-2019-0019-02 as proposed.

#### **Contested and Discussion Items**

 R7-2021-0052 – Consideration of adoption of Waste Discharge Requirements for Dredged or Fill Discharges to Waters of the State for California Department of Water Resources, Vegetation Enhancement Project at Clubhouse, Tule Wash, and Bombay Beach West Sites, Imperial County [Kai Dunn, Sr. WRCE]

Kai Dunn, Senior Water Resources Control Engineer, introduced the item and provided an overview of the proposed Order regulating a vegetation enhancement project aimed at improving conditions around the Salton Sea, including requirements to protect waters of the state.

5. <u>R7-2021-0025</u> – Consideration of adoption of Waste Discharge Requirements for Water Reclamation Plant No. 7, owned and operated by Coachella Valley Water District, located in Indio, Riverside County [*Reginald Tan, WRCE*]

The Board Chair pulled Item #5 to be heard at a future meeting.

6. <u>R7-2021-0050</u> – Consideration of adoption of General Waste Discharge Requirements for Discharges of Waste from Irrigated Agricultural Lands for Dischargers that are Members of a Coalition Group in the Imperial Valley, Imperial County [Jennie Snyder, WRCE]

Jennie Snyder, Water Resources Control Engineer, provided an overview of key proposed permit provisions and updates, including those relating to precedential requirements from State Water Board Order WQ 2018-0002, *In the Matter of Review of Waste Discharge Requirements General Order No. R5-2012-0116 for Growers Within the Eastern San Joaquin River Watershed that are Members of the Third-Party Group.* She also discussed comments received and staff's responses to those comments.

7. <u>R7-2021-0053</u> – Consideration of adoption of a Resolution for Certification of the Final Environmental Impact Report for the Oberon Renewable Energy Project, Riverside County [Logan Raub, ES]

Prior to the hearing, the Board Members were provided with a Late Changes Sheet specifying changes to Attachment A (Final Environmental Impact Report) and Attachment B (Mitigation Monitoring & Reporting Program) of the Resolution. The Late Changes Sheet was also posted to the Board's website during the hearing.

Logan Raub, Environmental Scientist, introduced the item and provided an overview of the proposed Resolution, including background on the Oberon Renewable Energy Project, the California Environmental Quality Act, and the Environmental Impact Report, including the various Project alternatives, significant comments received during the public comment period for the draft Environmental Impact Report, and staff responses. David Lancaster, an attorney from the Office of Chief Counsel, provided an overview of the Findings of Fact and Statement of Overriding Considerations. Logan Raub concluded the presentation with a specific reference to the Late Changes Sheet (discussed above).

8. <u>R7-2021-0048</u> – Consideration of Adoption of Waste Discharge Requirements for Dredged and Fill Discharges to Waters of the State for IP Oberon, LLC and IP Oberon II, LLC, Oberon Renewable Energy Project, Riverside County [Logan Raub, ES]

Logan Raub, Environmental Scientist, introduced the item and provided an overview of the proposed Order, including information about the Oberon solar facilities avoidance and mitigation measures to protect waters of the state, the solar facilities unavoidable and unmitigable impacts, and compensatory mitigation.

#### **Informational Items**

- 9. Colorado River Basin Water Board Executive Officer's Report [Paula Rasmussen, EO]
  - 2022 Board meetings may be transitioning to "hybrid" meetings that are both in person and online beginning February 2022. This would require a Board quorum to be physically present at the meeting.
  - On December 7, 2021, the State Water Board approved the Basin Plan Amendment for the Yucca Valley Septic Tank Prohibition (Maria Davydova, ES)
  - Tribal consultation letters were issued for the Total Maximum Daily Load project for pyrethroids pesticides in Imperial Valley (Lauren Briggs, ES)
  - Staff participated in a tour of the Species Conservation Habitat Project at the Salton Sea provided by California Natural Resources Agency.

- Staff participated in the California-Mexico Board Relations Council meeting held on December 13, 2021 via virtual format. Updates were provided on COVID-19 responses at the border, wastes, and transportation.
- Staff will participate in a kickoff meeting for the Salton Sea Long Range Planning Committee later in December to discuss the purpose of the long range plan, committee charge, and the state of the Salton Sea.
