5. Workshop – Draft Imperial Valley Irrigated Lands General Waste Discharge Requirements [Jennie Snyder, WRCE]

Jennie Snyder, WRCE, introduced the item and provided background on the history of the Irrigated Lands Program and an overview of key proposed permit provisions for the draft General Waste Discharge Requirements for Discharges of Waste from Irrigated Agricultural Lands for Dischargers that Are Members of a Coalition Group in the Imperial Valley, including those relating to precedential requirements from State Water Board Order WQ 2018-0002, In the Matter of Review of Waste Discharge Requirements General Order No. R5-2012-0116 for Growers Within the Eastern San Joaquin River Watershed that are Members of the Third-Party Group.

6. Administrative Enforcement [Paul Ciccarelli and David Boyers, Office of Enforcement]

David Boyers, Assistant Chief Counsel with the Office of Enforcement, and Paul Ciccarelli, Attorney III with the Office of Enforcement, provided an overview of separation of functions, mandatory minimum penalties and discretionary enforcement legal authorities, the State Water Board's *Water Quality Enforcement Policy* and *Policy on Supplemental Environmental Projects*, and options for settlement of administrative civil liability.

7. Salton Sea Update [Assistant Secretary Arturo Delgado, California Natural Resources Agency]

Arturo Delgado, Assistant Secretary for Salton Sea Policy for the California Natural Resources Agency, provided a program overview and update on the Salton Sea Management Program 10-Year Plan, including progress on implementation of the Species Conservation Habitat Project.

- 8. Colorado River Basin Water Board Executive Officer's Report [Paula Rasmussen, EO]
  - Recent legislation was approved that allows virtual meetings through the end of January 2020. Future board meetings will continue in the virtual format, although the State Water Board is working on technology to allow an option for in person attendance.

- The Water Quality Coordinating Committee meeting will be held in a virtual format on October 21st and 22<sup>nd</sup>. The focus of this year's WQCC meeting is 50 years of the Clean Water Act and Porter Cologne. The Regional Water Board will share a success story at the meeting.
- On October 5th, staff requested external scientific peer review of a proposed Basin Plan Amendment that would establish Total Maximum Daily Loads (TMDLs) for the Alamo River, Imperial Valley drains, New River, and Weist Lake for organophosphate and organochlorine compounds. Staff intends to present the Basin Plan Amendment and TMDLs for Board consideration in April.
- Staff recently sent a letter soliciting tribal consultation for the establishment of TMDLs for ammonia and toxicity in the New River. A CEQA scoping meeting is tentatively planned for mid-November following the completion of tribal consultation.
