5. Waste Discharge Requirements Order R7-2022-0037 and Monitoring and Reporting Program Palm Springs Aerial Tramway, Mountain Station Staff Contact: Reginald Tan, WRC Engineer

The Vice-Chair administered the Oath to those intending to speak on this item. Staff provided information relevant to the proposed as it pertains to the Waste Discharge Requirements for Palm Springs Aerial Tramway, Mountain Station Wastewater treatment and disposal system. Staff described the facility, permit requirements, new monitoring requirements, the Discharger comments, and staff responses. Staff recommended that the Board adopt the proposed order.

6. Waste Discharge Requirements Special Order R7-2022-0022 to revise Waste Discharge Requirements, National Pollutant Discharge Elimination System (NPDES Permit CA0104523), for the City of Brawley Wastewater Treatment Plant Staff Contact: Jose Valle deLeon

The Vice-Chair administered the Oath to those intending to speak on this item. Staff provided information relevant to the proposed as it pertains to the Waste Discharge Requirements, Pretreatment Program and NPDES permit for the City of Brawley Wastewater Treatment Plant. Staff described the facility, revised permit requirements for effluent limits, status and approval of local limits study and modifications for industrial users. Staff recommended that the Board adopt the proposed order with the verbal change request referenced in footnote 5 for local limits study approved April 18, 2022, by the Executive Officer in revision number 3 of the proposed order. 8. Species Conservation Habitat Update, Miguel Hernandez, Public Affairs Officer of the California Natural Resources Agency (CRNA) Salton Sea Management Program

Mr. Hernandez presented an introduction of the key priorities and future projects at the Salton Sea and the Species Conservation Habitat Project (SCH) at the south end of the Salton Sea.

Ms. Rasmussen reminded the Board that the Water Quality Control Committee meeting will be held in Sacramento October 27-28, 2022.

10. Comments from Board Members

Board member Wright thanked the presenters for their presentations and is happy to be back in Brawley after the long absence due to COVID 19. Board member Muzik apologized for not being present in person and is sorry he won't be able to participate in the tour. Board member Gonzalez likes the idea of having meetings in various cities in the region and would encourage more remote meetings in the future. Board member Gonzalez has toured the Salton Sea and is excited to see all of the work being done in and around the area and the efforts of our elected representatives in generating financial support for the Salton Sea and New River projects that benefit the community and the State.

11. Report from Chair, Jayne Powell

Chair Powell encouraged attendance at the Water Quality Coordinating Committee (WQCC) meeting later this month. A Chair's call was held on October 4th during which John Russell presented an informative overview of the budget with handouts which will be distributed to the Board Members. Additional topics discussed on the call were the 2 million dollars in drinking water and wastewater funds from the federal government, appointment and position allocations,

a discussion about the water supply strategy, and a legislative update. The legislative update will be distributed to the Board Members once it has been finalized.
