The Executive Officer (EO) of the California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) hereby provides the following report on recent staff activities in the region:

LAND DISPOSAL - WASTE DISCHARGE REQUIREMENTS PROGRAM

In addition to the standard workload of writing Board Orders, performing Facility Inspections, and reviewing Discharge Monitoring Reports, staff of the Land Disposal Unit completed the following tasks:

Meetings: On May 21, 2020, staff attended the Salton Sea Authority Board of Directors Meeting. A presentation was provided by the City of Calexico regarding the New River Improvement Project (NRIP). The City of Calexico mentioned that the addition of the disinfection facility, which was originally a part of the NRIP but later omitted due to the price tag, is under consideration. The City of Calexico expressed their desire to take this request, through the Colorado River Basin Regional Board, to the California-Mexico Borders Relation Council in the future. New River Monitoring: On May 19, 2020, staff assisted in the monthly water quality monitoring event for the New River at the International Boundary. [Reginald Tan, WRCE]

Notices of Violation: Three (3) Notice of Violations were issued to Dischargers for violations of their Waste Discharge Requirements.

WATER QUALITY STANDARDS PROGRAM

Coachella Valley Environmental Justice Enforcement Task Force, May 20, 2020:

Staff coordinated with Comite Civico del Valle to organize and co-chair the monthly Coachella Valley Environmental Justice Enforcement Task Force. The meeting is typically held in Indio but is being temporarily conducted online over GoToWebinar. Meeting participants included CalEnergy, City of Coachella, South Coast AQMD, Riverside County Agricultural Commissioner's Office, 29 Palms Band of Mission Indians, Department of Pesticide Regulation, Air Resources Board, Torres Martinez Desert Cahuillla Indians, and Chiriaco Summit. Comite Civico del Valle reported that they are focused on census work right now. 29 Palms reported that they would be opening their casinos on Friday 5/22 with health precautions. California Natural Resources Agency (CNRA) will soon release an updated dust suppression action plan (DSAP) for the Salton Sea, revised from 12 to 60 pages based on public comments taken in December and January. A Salton Sea Authority meeting was announced for 5/21 to discuss the New River Improvement Project. [Maria Davydova, ES]

NPDES PROGRAM

Pretreatment Compliance Inspection: The practice of removing pollutants from industrial and commercial wastewater before they are discharged into a municipal sewage treatment system is known as "pretreatment." Three onsite Pretreatment Compliance inspections for NPDES facilities were conducted by the USEPA contractor State Water Board staff and Regional Water Board staff (inspection team) remotely due to the COVID 19 pandemic limitations.

On May 26, 2020, the inspection team conducted a virtual information review as part of the Pretreatment Compliance Inspection (PCI) of the City of Brawley's formally approved pretreatment program. The following documents were reviewed during the PCI: Sewer Use Ordinance, Local Limits, Enforcement Response Plan, NPDES permit, most recent Pretreatment Program Annual Report, most recent significant noncompliance publication, and significant industrial user files. There are three significant industrial users in the program; 1) Beef Packing Plant, 2) Hospital and 3) Food Processing Plant. The inspection team will inspect the significant industrial user facilities in person after the COVID-19 restrictions are relaxed. [Kai Dunn, Ph.D., P.E., Senior WRCE, Jose Valle de Leon, WRCE]
