CANNABIS ENFORCEMENT

Region 7's Prosecution team has issued three Administrative Civil Liability Complaints (Complaints) which are currently posted on our website and available for public review. All three complaints are referencing violations of the Cannabis Cultivation General Order that address waste discharges associated with cannabis cultivation activities.

The Dischargers chose to waive the right to a Hearing before the Regional Board to engage the Regional Board's Prosecution Team in settlement discussions including the possibility of completing a Supplemental Environmental Project (SEP) and/or Compliance Projects. The Prosecution Team is currently in settlement discussions with the Dischargers.

NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PROGRAM

Seeley County Water District Wastewater Treatment Compliance Project Status Update

On February 28, 2019, the Colorado River Basin Water Board adopted a Settlement Agreement and Stipulation for Entry of Administrative Civil Liability of \$297,000.00 (Order R7-2019-0001) for Seeley County Water District (District) wastewater treatment plant. The settlement allows the total penalty amount to be suspended pending the completion of a compliance project (Project). The Project includes investigating and identifying the source(s) of copper and cyanide, eliminating and/or controlling the source(s) of copper and cyanide. The District has continued its efforts to identify the source(s) of copper and cyanide by monitoring waste streams brought to its facility for disposal through sampling and analyses of dump stations and the town's collection system. Due to COVID-19, the District's receiving station continues to operate under a modified schedule. Major revisions have been made to the proposed receiving station design through conversations between the District and the design engineer. The new proposal will simplify construction and installation by making use of the existing pond infrastructure. The District, its Board of Directors and their consultant engineer are aware of the February 1, 2022, compliance date to have the dump station design fully completed. *[Maribel Pizano, SEA; Kai Dunn, Ph.D., P.E., Senior WRCE]*

Imperial Irrigation District El Centro Generating Station Pollution Prevention Plan Status Update

On July 9, 2020, the Colorado River Basin Water Board adopted a Time Schedule Order R7-2020-0019 (2020 TSO) which includes compliance with Interim Effluent Limits specified for new or more stringent final effluent limitations included in Waste Discharge Requirements in Order R7-2020-0006 (2020 WDR) for Imperial Irrigation District's (IID) El Centro Generating Station. The 2020 WDRs include effluent limitations for two new compounds – lead and thallium – and more stringent effluent limits, IID requested a TSO to allow sufficient time to bring the Station into compliance with the 2020 WDRs. The Colorado River Basin Water Board responded by adopting the requested TSO, Order R7-2020-0019, (2020 TSO) on July 9, 2020. IID has developed and submitted a Pollution Prevention Plan (PPP) that was submitted on October 30, 2020. The PPP included a plan to initiate the Feasibility Study. IID plans to initiate the study in the 1st Quarter of 2021. [*Jose Valle de Leon, WRCE; Kai Dun, Ph.D., P.E., Senior WRCE*]
