ADMINISTRATIVE CIVIL LIABILITY COMPLAINT NO. R7-2008-0023
ISSUED TO
CITY OF CALIPATRIA, OWNER/OPERATOR,
MUNICIPAL WASTEWATER TREATMENT PLANT
FOR
DISCHARGES OF EFFLUENT THAT EXCEED THE EFFLUENT LIMITATIONS
IN VIOLATION OF BOARD ORDER NO. R7-2005-0085
NPDES PERMIT NO. CA0105015

The City of Calipatria (Discharger) owns and operates a municipal sewage collection system and wastewater treatment plant. The collection system provides conveyance of raw wastewater to the treatment facility through both separate and combined sewer lines. The wastewater treatment plant is designed to treat municipal wastewater flows of up to 4.3 million gallons per day. On June 29, 2005, the California Regional Water Quality Control Board, Colorado River Basin Region (Regional Board) adopted Waste Discharge Requirements, and a National Pollutant Discharge Elimination System (NPDES) Permit to regulate the discharge of treated municipal wastewater to the "G" Drain. The Permit is assigned NPDES Permit No. CA0105015, Board Order No. R7-2005-0085.

The Assistant Executive Officer of the Regional Board has issued Administrative Civil Liability Complaint No. R7-2008-0023 against the Discharger, alleging that the Discharger discharged wastewater that exceeded effluent limits set forth in Board Order No. R7-2005-0085. Pursuant to Section 13385 of the California Water Code, this complaint proposes that the discharger pay one hundred fifty thousand dollars (\$150,000) in mandatory minimum penalties for violations of specified effluent limitations. The Discharger may propose to spend a portion of that amount toward the implementation of a Supplemental Environmental Project that is consistent with the Water Quality Enforcement Policy (Policy). The State Water Resources Control Board adopted the Policy on February 19, 2002 as Resolution No. 2002-0040, and it was approved by the Office of Administrative Law and became effective on July 30, 2002.

Unless the Discharger agrees to waive its right to a public hearing on the matter, as provided by California Water Code Section 13323(b), the Regional Board will proceed with the public hearing as follows:

Location: Indio City Council Chambers

During the hearing, the public and any other person interested in this matter can provide the Regional Board with comments on this matter.

If the Discharger waives its right to the hearing and pays the Administrative Civil Liability in full, the Regional Board may still decide to conduct a hearing on this matter. The settlement of this Complaint will become final 30 days from the date of this Public Notice. Persons wishing to file written comments on, or objections to, the proposed Administrative Civil Liability Complaint or any other aspects of this matter are required to do so within 30 days of the date of this Notice so that the Regional Board may consider the comments.
