# NOTICE OF PUBLIC HEARING FOR WASTE DISCHARGE REQUIREMENTS PROPOSED ORDER R7-2019-0018

The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) has prepared proposed Order R7-2019-0018 (Proposed Order) for the North Brawley Geothermal Power Plant, located north of Brawley, Imperial County, California (Facility). The Facility, which includes a 49.9-megawatt power plant and associated well fields and infrastructure, is operated by Ormat Nevada Inc. (Ormat). The power plant is owned by Orni 19 LLC, a wholly owned subsidiary of Ormat. A separate wholly owned subsidiary, Orni 17 LLC, leases private land from various surrounding landowners upon which are located the geothermal exploration, production, and injection wells associated with the power plant. All three entities would be regulated by the Proposed Order.

The Colorado River Basin Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:

### **SUBMISSION OF WRITTEN COMMENTS**

The Colorado River Basin Water Board will accept written comments regarding this Proposed Order during a 30-day public comment period, which begins **October 3, 2019** and ends **November 2, 2019**. Persons wishing to submit written comments on the Proposed Order are requested to do so as soon as possible, but no later than **November 2, 2019**.

### **HEARING PROCEDURE**

Affected stakeholders and other interested persons are invited to attend and express their views orally on this matter at the public hearing. The Colorado River Basin Water Board requests that those persons wishing to speak at the hearing provide a copy of their oral comments in writing before or during the hearing to ensure accuracy of the record.

Those who wish to speak at the hearing will be asked to fill out a speaker request card and provide it to Colorado River Basin Water Board staff. Comments from the public will be limited to three (3) minutes per person. Any person planning to make a presentation to the Colorado River Basin Water Board that requires the use of visual aids (such as overheads, slides, or video projector) should contact the assigned staff person to make arrangements before the meeting date in order to avoid unnecessary delays during the meeting. Where speakers can be grouped by affiliation or interest, such groups will be expected to select a spokesperson and not be repetitive.
