NOTICE OF PUBLIC HEARING FOR WASTE DISCHARGE REQUIREMENTS FOR MITSUBISHI CEMENT CORPORATION, CUSHENBURY PLANT LANDFILL PROPOSED ORDER R7-2020-0016

The California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) has prepared proposed Order R7-2020-0016 (Proposed Order) for the Mitsubishi Cement Corporation, Cushenbury Plant Landfill (Facility), located about eight miles south of Lucerne Valley, California. The Facility is comprised of an active, Class III, inert waste management unit (WMU). The WMU footprint encompasses a total of 15 acres. The property is privately owned and is solely for the solid, inert waste generated by the Discharger. The Facility is not open to the general public and no public roads are used for transporting any off-site waste to the landfill site.

The Regional Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:

Those who wish to speak at the hearing will be asked to fill out a speaker request card and provide it to Regional Water Board staff. Comments from the public will be limited to three (3) minutes per person. Any person planning to make a presentation to the Regional Water Board that requires the use of visual aids (such as overheads, slides, or video projector) should contact the assigned staff person to make arrangements before the meeting date in order to avoid unnecessary delays during the meeting. Where speakers can be grouped by affiliation or interest, such groups will be expected to select a spokesperson and not be repetitive.
