ISSUED TO SAN BERNARDINO COUNTY FLOOD CONTROL DISTRICT CULVERT REPLACE – EL REY AVENUE CROSSING AT 29 PALMS CHANNEL PROJECT

The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2020-0037 (Proposed Order) to the San Bernardino County Flood Control District (Permittee) for the Culvert Replacement – El Rey Avenue Crossing at 29 Palms Channel Project (Project). The Project site is located at the Twentynine Palms Channel and El Rey Avenue, a key north/south local street for the City of Twentynine Palms. The Project is expected to impact waters of the state.
