ISSUED TO SONORAN WEST SOLAR HOLDINGS, LLC AND SONORAN WEST SOLAR HOLDING 2, LLC CRIMSON SOLAR PROJECT - BATTERY ENERGY STORAGE SYSTEM

The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2020-0021 (Proposed Order) to Sonoran West Solar Holdings, LLC (Permittee) and Sonoran West Solar Holdings 2, LLC (Co-Permittee) for the Crimson Solar Project - Battery Energy Storage System (Project). On July 20, 2021, the Board adopted Order R7-2021-0035, Waste Discharge Requirements for dredged or fill discharges from the Project. On August 11, 2021, Colorado River Basin Water Board staff received a notification and report from the Permittee that there will be a partial transfer of property ownership of the Project facility. Order R7-2021-0035 needs to be amended to incorporate the new owner(s) of the Project facility.
