# WASTE DISCHARGE REQUIREMENTS FOR DREDGED OR FILL DISCHARGES TO WATERS OF THE STATE PROPOSED ORDER R7-2021-0010

### ISSUED TO TRI-POINTE HOMES CORONA, CALIFORNIA

The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2021-0010 (Proposed Order) for Tri-Pointe Homes IE-SD, Inc. (Permittee) for the Atwell Phase III – V Development Project (Project). The Project would construct a master-planned community and associated infrastructure over approximately 473 acres of land for the City of Banning. The Project will include the construction of 1,768 low and medium density residential units, parks, open space land use components, and associated on and off-site infrastructure. The Project is expected to impact waters of the state.

The Colorado River Basin Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:

#### SUBMISSION OF WRITTEN COMMENTS

The Colorado River Basin Water Board will accept comments during a 30-day public comment period, which begins **March 11, 2021**, and ends **April 12, 2021**. Written comments on the Proposed Order must be received no later than **5:00 p.m., April 12,** 

**2021**. Comments received by this deadline will be included in the administrative record. If written comments to the Colorado River Basin Water Board are not timely submitted, however, the Board Chair may refuse to accept such evidence or admit it into the administrative record unless the commenter can demonstrate why he or she was unable to timely submit the evidence, that compliance with the deadline would create an unreasonable hardship, or that allowing the evidence would not prejudice any party or the Colorado River Basin Water Board. (Cal. Code Regs., tit. 23, § 648.4.)
