Staff of the California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) have prepared tentative Waste Discharge Requirements (Tentative WDRs) R7-2021-0012 for the Needles Sanitary Landfill located on Highway 95 south of Needles, California 92363, in San Bernardino County. The Regional Water Board intends to consider adopting the Tentative WDRs during a public hearing that will commence at the following date and time, by **video and teleconference only**:
