ISSUED TO SONORAN WEST SOLAR HOLDINGS, LLC CRIMSON SOLAR PROJECT – BATTERY ENERGY STORAGE SYSTEM

The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2020-0035 (Proposed Order) to Sonoran West Solar Holdings, LLC (Permittee) for the Crimson Solar Project – Battery Energy Storage System (Project). The Project site is located immediately south of Interstate 10 (I-10) and approximately 9 miles west of State Route (SR) 78 and the City of Blythe - Riverside County, California. The Project is expected to impact waters of the state.

The Colorado River Basin Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:
